Charges for the Direct Cremation Package include the basic services of the funeral director and staff, picking up and bringing your loved one into our care from the place of passing, sheltering the decedent in refrigeration, the cremation process (non-witnessed), completing and processing a signed death certificate, filing the certificate and permit with the local health department, an alternative container (cardboard) for the cremation, Opal’s hand-crafted rosewood urn, one copy of the certified death certificate, and a choice of either shipment via USPS special service priority shipping within the US or pick up at one of our locations in Southern California. Applicable filing fees and taxes for items in the package are included. *Cremation will occur within approximately seven (7) working days of receiving required county permits.*

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of cardboard.

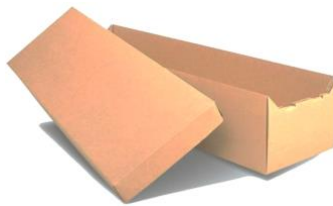
